

History of the South Atlantic District Updated 30 November 2016 by Lawrence G. Fehrenbaker, Sr., MD VPG 2016-2017

Perspective

In 1949, the South Atlantic District (SAD) of the National Society of the Sons of the American Revolution was established as a functional unit of the National Society. It consisted of five state societies: North Carolina, South Carolina, Georgia, Florida, and Virginia.

In 1973, Virginia was transferred to the Mid Atlantic District, leaving the South Atlantic District with its current four states consisting of Florida, Georgia, North Carolina and South Carolina. In 1983, the Foreign District was renamed the European District, and in 1985 the Western Hemisphere District was formed to give the NSSAR its total of 15 Districts. The Western Hemisphere District was later renamed the International District.

At the South Atlantic District meeting in Charlotte, NC in 2002, it was proposed and approved that the VPG provide, on an annual basis, an updated History of the South Atlantic District. The purpose of the annual update is to inform the State Societies of our common goals and history; to list select schedules of events; and to act as a forum for the Vice President General to communicate with SAD State Society Presidents, State Society Chapters and the National Society.

The South Atlantic District isn't an entity in its own right. It's an integral part of the National Society and exists to carry out the functions of the National Society. The VPG is elected by Congress as a national officer. According to protocol he is the second ranked officer when he is in his district. Under this circumstance he is only out-ranked by the President General. Thus, one of his functions is to be a representative of the President General when he isn't present and to be the host of the President General when he is present.

The VPG as well as all district members are tasked to assist in the implementation of the goals established each year by the President General. The South Atlantic District has been and will continue to be a leader in achieving and implementing the goals of our President General.

The request for a visit by the President General begins at the Annual National Congress. It is highly recommended that each State President have a request available at Congress so that it may be presented to him upon his election. The President General's Travel Coordinator should be notified as early as possible of all requests for a visit to a South Atlantic District state society. A concise summary to make the President General's visit a great one is included in this update, on pages 12 and 13. The South Atlantic District VPG welcomes the opportunity to assist State Society Presidents in coordinating a visit from the President General or his designee. The proper protocol for hosting the President General and for conducting SAR meetings is published in the NSSAR Official Handbook and further discussed on pages 11 and 12.

This History of the South Atlantic District is a continuing effort. Hopefully, it will serve as another tool to improve communication to the four State Presidents and the chapters in their respective states. It is only as good as the input we receive. Therefore, additions or corrections are welcomed.

Comments, corrections, and/or recommendations should be addressed to the incumbent VPG or the Secretary of the South Atlantic District.

District Overview

As promulgated in the Bylaws of the South Atlantic District, the position of Vice President General rotates through the four State Societies. The State Society, next in rotation, usually selects their candidate for VPG at its Annual State Meeting and is confirmed as the nominee at the Annual Meeting of South Atlantic District. The election and installation of the South Atlantic District Vice President General takes place at the Annual National Congress.

The incumbent VPG usually conducts the Annual South Atlantic District meeting in conjunction with his State Society's Annual Meeting. The four State Society Presidents and National Trustees of the various State Societies, along with all past South Atlantic District VPGs should be invited to attend the Annual South Atlantic District Meeting. NSSAR officers should also be invited to the annual meeting and all other District meetings.

State Society Presidents should submit a report summary of their State's activities, which provides important accomplishments, membership status, new chapters, and any other item of interest. These reports are submitted to the VPG as specified by him, so that he may include them in his Reports which are submitted to the NSSAR (through the Executive Director) and are published in the Semi-Annual Committee and General Officer Reports for publication in the Leadership/Trustees Meetings and the Annual Congress. The due date will be announced by the VPG to allow sufficient time for preparation of the Reports. Reporting by email is the best method of transmittal.

After considerable effort and consultation, By-Laws of the South Atlantic District were adopted unanimously by the assembled members of the district at the Annual District meeting on April 2, 2011 in Columbia, SC. These by-laws, the first ever adopted for the district, reaffirmed our objectives, established membership, governing authority, meetings, nomination and election of the vice president general, parliamentary authority and the amendment process. In testament of adoption copies were signed by Vice President General Redding I. (Rick) Corbett III and District Secretary Mark C. Anthony.

Note: The adopted by-laws' established rotation selection process was temporarily suspended in 2012 due to a conflict caused by the Florida Society's by-laws. The Florida Society selection for VPG was withdrawn for not meeting their society's requirements and they were unable to provide another selectee. A subsequent agreement was reached by the District for the next society in rotation, the North Carolina Society, to provide a selectee for 2012, followed by the Florida Society in 2013, and then back to normal rotation with South Carolina in 2014. Changes were made in the District's By-Laws to address any future conflicts of this nature. The Florida Society subsequently removed restrictions in their by-laws where they pertain to service as Vice President General.

District Membership¹

As of 23 December 2013, the South Atlantic District membership totals 5,471 Compatriots.

- North Carolina has 1,017 members in 26 chapters
- South Carolina has 823 members in 18 chapters
- Georgia has 1,718 members in 32 chapters
- Florida has 1,913 members in 33 chapters

South Atlantic District National Revolutionary War Events. The South Atlantic District recognizes its States' contribution to the final success of the American Revolution and their historical importance for our Nation. Three of the original 13 States, and ten of the 56 Signers of the Declaration of Independence came from this District. The South Atlantic District is particularly well situated to lead the way in recognition of historical events as illustrated by the Revolutionary War Battles enumerated below.

North Carolina Society

The North Carolina Society was organized 31 March 1911. It hosted the 42nd National Congress in Charlotte in 1931and the 121st National Congress in Winston Salem in 2011. The North Carolina Society annually commemorates the following **National Events**:

• **The Battle of Moores Creek Bridge** is celebrated on the last Saturday in February in Currie, NC (near Wilmington). It is hosted by the Lower Cape Fear Chapter.

• **The Battle of Guilford Courthouse** is observed on the Saturday nearest the March 15 anniversary of the battle in Greensboro, NC.

• **The Halifax Resolves** is celebrated on the second Saturday of each April in Halifax, NC, and is hosted by the Halifax Resolves Chapter.

• **The Battle of Ramsour's Mill** is celebrated the third weekend of each June in Lincolnton, NC. It is hosted by the Catawba Valley Chapter.

North and South Carolina Societies

In May of 2008, a mutual agreement was reached between Dr. Samuel C. Powell, President of the North Carolina Society, and Dr. Redding I. Corbett III, President of the South Carolina Society. The Battle of Kings Mountain became a joint celebration sponsored by both of these state societies. Since the battlefield is entirely within South Carolina, the South Carolina Society hosts the commemoration of this event. In recent years and although not to do so, the South Atlantic District has held its fall meeting in conjunction with the Battle of Kings Mountain celebration.

• **The Battle of Kings Mountain** is celebrated on October 7 at the National Military Park, near Blacksburg, SC. The battlefield events are coordinated by the North Carolina Society's Mountain District and the Blue Ridge Chapter. The South Carolina Society hosts a reception the evening before the celebration in Gaffney, SC.

South Carolina Society

The South Carolina Society celebrates the following annual National Event:

• **The Battle of Cowpens** is celebrated on the second or third Saturday in January at the National Military Park in Chesnee, SC. On the day before this event, a separate ceremony is held in downtown Spartanburg, SC at the General Daniel Morgan statue honoring the masterful leadership of the commander of the Patriot forces during the battle. The entire weekend event is hosted by the Daniel Morgan Chapter.

South Carolina is the oldest Society in the District, having organized 18 April 1889. The land of Francis Marion, South Carolina's numerous battle sites outnumber those of any other state in the nation. The Society continues to pursue opportunities to commemorate other battle sites that may become National events. The South Carolina Society hosted the 124th National Congress in Greenville in 2014.

Georgia Society

The Georgia Society was organized 15 March 1921. It hosted the 93rd National Congress in 1983 in Atlanta and the 119th National Congress in 2009 in Marietta, the NW Atlanta area. In colonial times, the settled area of Georgia was approximately the 16 counties along the Savannah River and the Atlantic Ocean. Most of current day Georgia was Indian Territory during the Revolution.

The Georgia Society celebrates the following annual National Events:

• The Battle of Kettle Creek took place on February 14, 1779, and is celebrated on the second Saturday of each February at the battle site just outside Washington, GA. It is hosted by the Georgia Society. It commemorates the major defeat of the British in Georgia.

• **The Battle of Savannah** is commemorated on 9th at the battle site in downtown Savannah, GA. The death of General Casimir Pulaski occurred at this battle.

Florida Society

The Florida Society celebrates the following annual National Events:

• The Last Naval Engagement of the American Revolution. This battle occurred off the coast of Florida, just south of Cape Canaveral, on 10 March 1783. First celebrated in 2007 on the 10 March anniversary date, 2008 was the 225th celebration and was held on 8 March. The battle is usually celebrated on the weekend nearest to the 10th, and is hosted by the Brevard Chapter.

• **The Battle of Pensacola.** This ceremony celebrates the 1781 battle that resulted in the British surrender of Florida! This event recognizes the important role Spain played in the American Revolution. The first ceremony occurred on 8-9 May 2009 and continues to be celebrated on the weekend nearest to the actual battle anniversary.

Florida is home to the largest SAR population in the District. The Society's accomplishments continue to set an example for the rest of the District. Past State President Joseph A. Rumbaugh established a \$100,000 Trust Fund in 1992 to found the Oration

Contest that bears his name. It is one of the highlights of every National Congress, and a showcase for young orators.

The Florida Society hosted both the 96th National Congress in Tampa in 1986 and the 108th National Congress in Orlando in 1998. Organized on 14 March 1896, it is the second oldest Society in the District, behind South Carolina.

Since 1949, Vice President's General have been identified as representing and charged with oversight of the several geographic Districts of the Society. Their roll has been to support and mentor the officers of the State Societies in their District; and to promote the implementation of State goals and programs, and the goals and programs of the National Society.

The VPsG met informally until 1999. In July 1999, President General Howard Horne instituted The Council of Vice Presidents General. It was charged with being:

- Responsible for providing advice and counsel to the President General.
- Assisting the President General's VPG coordinator in arranging visits to the District and State Societies.
- Helping with arrangements for the Incoming State and Chapter President's Seminar at the Spring National Leadership Meeting.

Revised Responsibilities

President General Larry McClanahan submitted a Long Range Plan 2001 to 2021 at the 2001 Congress that reorganized the structure of the National Committees. The Council of Vice Presidents General was placed under the responsibility of the **Secretary General**. All General Officers are included in the "Council of General Officers", and have expanded roles to assist in Society activities and committee operations.

We plan to continue to see that our district meetings are well planned and effective and that state officers who need some senior guidance receive it from their Vice President General or some other trusted and experienced source. We have a major responsibility for setting the tone of the Society and for guiding the efforts of the officers of the state societies toward the most constructive and effective paths. Our vigor and dedication to SAR goals and programs should be an example and a catalyst for trustees, national committee chairmen and members, and all who meet us within and outside the Society. We have a special responsibility to reach outside the SAR to attend or meet with high- ranking officials in other societies to promote cooperation that is consistent with SAR goals. Whenever a new role is assumed in the SAR, there are few notes available as to how to actually do the job being assumed. Input from past VPsG will be solicited to enable future VPsG an insight as to what is expected.

PROTOCOL (Extracted from NSSAR Handbook, October 1, 2016, Vol. IV, page 12).

Observance of established rules of protocol will increase the prestige and dignity at SAR functions. The basic principles of protocol are to: 1. Observe the rules of ranking of office. 2. Practice courtesy. 3. Use good judgment.

President General: The President General is the ranking officer of the National Society and should be regarded as the honor guest at all SAR functions. The State Society President is the highest-ranking officer in his State Society and should be accorded such recognition. **In his State** he outranks a Vice President General. The Chapter President is the ranking officer, in his Chapter.

President General Title: All former presidents general retain their title for life, and will be addressed as President General. They should identify their years of office when writing or signing. It is proper when writing about them to identify them as (for example) former President General Jones (1994-95) using small "f" with former.

Sequence of Seniority: The sequence of seniority is National Society, State Society and Chapter.

Ranking of National Society Officers: The following may be used as a guide for state societies and chapters: President General, Vice President General, Secretary General, Treasurer General, Chancellor General, Generalogist General, Registrar General, Historian General, Librarian General, Surgeon General, and Chaplain General.

Ranking of State and Chapter Officers: The ranking of State and Chapter officers is the responsibility of the State and Chapter.

Ranking at SAR Functions: When National Society officers and State Presidents and/or officers of other organizations are present at SAR functions, their ranking may be determined by the office held and the organizational date of the respective society. The following may be used as a guide of precedence for a possible State Society function: State Society President, President General, Governor of State, or his Representative, United States Senator, United States Congressman, Mayor of City, former Presidents General, National SAR Officers in order of seniority, visiting State Society Presidents, active Host State Society Officers, Former National Society Officers, National Presidents of other organizations, State Presidents of other societies.

Seating at National Society functions: the President General, as presiding officer, occupies the place at the center. The order of precedence is as follows: The place on the right of the President General is the next highest seat. The place on the left is the next highest seat, and on down the line alternating right to left.

Seating at State Society functions: The State Society President, as presiding officer, occupies the center place. The highest, ranking officer present is on the right. The next officer is on the left, following the precedence. At luncheons and banquets, the number of people attending should determine the size of the head table in a reasonable ratio to the assemblage. If ladies are included at the head table, the ladies and gentlemen should be alternated in seating. If possible a lady should not be seated in the last chair at either end of the table. A reserved front table can serve for a minister, musician, and lower ranking officers.

Greetings and Recognition: The highest-ranking guest should be introduced for any greeting, with others greeted in order of precedence. It is wise to limit the number of greetings. It is unfair to the speaker and to the audience to have lengthy and many greetings. In most cases a quick recognition will suffice. When introducing the head table, or other special reserved tables, announcement should be made to withhold applause until all are introduced.
