See you in a couple of weeks.

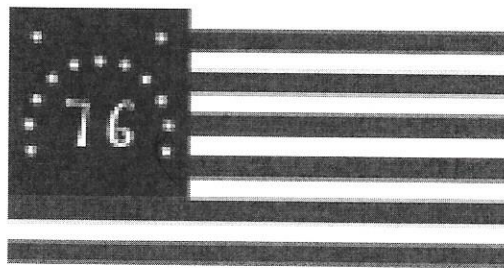

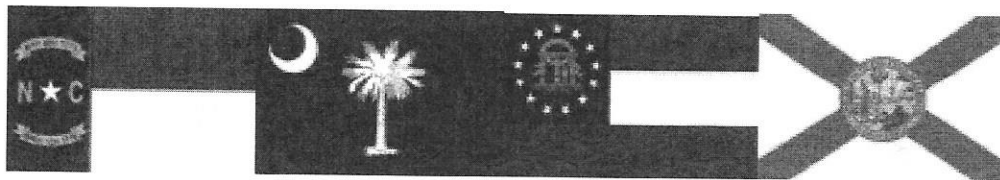

South Carolina Society Report

4 October 1010

The South Carolina Society is at mid-point of its 2010-2011 State Society Year. This report summarizes highlights of our SAR work since we last reported to the South Atlantic District on 24 April 2010 at Charlotte.

MEMBERSHIP

- At the beginning of Calendar Year 2010, the SC Society reported 684 members; at 29 September 2010 the Society membership was 746, a gain of slightly more than 9% or 62 members.
- Membership recruitment is a high priority of the State Society and Chapters are continually reminded of the importance of enlisting new members. Some Chapters maintain and work a list of potential new SAR members, inviting them to meetings, offering assistance with the application process and working well to assimilate them when membership is approved. Other Chapters, unfortunately, do not work at recruitment as they should and find themselves with ranks reduced and thus diminishing capacity for work and service.
- The State Society is seeking opportunities in public venues to tell the SAR story and to recruit new members. Plans are being formulated for a recruitment effort next year at the "Pioneer Day" program at Gray Court, SC. The "Pioneer Day" event is held in September (11 September in 2011) in the setting of a reconstructed pioneer village near Main Street in Gray Court. We will work with DAR in this venture.

NEW CHAPTERS

- Work continues on the organization of new Chapters of the State Society. Meetings are being scheduled for restarting the Newberry, SC Chapter (Philemon Waters Chapter) and for organizing a new chapter in Walterboro, SC. A study of underserved areas of the State is being conducted by the New Chapter Development Committee will assist in determining other new Chapter possibilities.

CAAH CAPITAL CAMPAIGN

- At the end of the Third Quarter of 2010, NSSAR reported that of 733 members showing in the "State Challenge" roster for South Carolina, 110 have made contributions to the CAAH Capital Campaign; this is 15% of the State membership. Total contributions at the end of September were \$19,145.00, an average of \$26.00 per member. Additional contributions are projected before end of the Calendar Year 2010, and SCSSAR expects to achieve the Goal of 20% of members contributing. The per member contribution goal will be harder to achieve, but we continue to work at it. In addition to the contributions of individual members, Chapters are also making substantial contributions of \$500.00 or more per Chapter of the State Society.

OTHER NEWS OF INTEREST

- The SC and NC Societies are jointly sponsoring the annual observance that commemorates the Battle of Kings Mountain on 7 October. SC will host a Reception following the South Atlantic District Meeting on 6 October.
- The Great Canebrake Commemoration will be held Saturday, 4 December (Colonel Robert Anderson Chapter, sponsor), and the Battle of Cowpens Commemoration is scheduled for Saturday, 15 January 2011 (General Daniel Morgan Chapter, sponsor).
- South Carolina's Annual State Meeting is scheduled for Friday-Saturday, 8-9 April 2011, in Columbia.
- Planning continues for SCSSAR to serve as Host Society for the 2014 National Congress in Greenville.
- We have made an effort this year to participate in commemorations conducted beyond SC. We participated in the Sycamore Shoals Gathering on 18 September, and will participate in the Siege of Savannah on 9 October. We appreciate participation in SC based/sponsored events by other States Societies in the District and beyond.

Report on Expenses related to 2010 Cowpens and Kings Mountain Reception

The SCSSAR hosted receptions on Friday, 15 January 2010 and Wednesday, 6 October 2010 for members of the SAR, DAR, CAR and others who were attending the 229th Anniversary of the Battle of Cowpens and the 230th Anniversary of the Battle of Kings Mountain. The SCSSAR also hosted breakfast on the mornings following each of the receptions for these same attendees.

A total of \$180.61 was spent toward the Cowpens reception and breakfast. Due to the time elapsed since that event, a detailed breakdown of the expenses is not available at this time, but should be similar to those reported for both Kings Mountain events.

At the Kings Mountain reception, approximately 60 individuals attended, of which 4 were from the SCSSAR representing 4 chapters. During Saturday morning breakfast, approximately 40 individuals attended, of which 3 were from the SCSSAR. There were attendees from SC, NC, GA, TN, KY, VA, DE, FL, AL, the District of Columbia, and California.

Attending the celebration were the President General and his wife, the Secretary General (and presumptive next President General) and his wife, Treasurer General, Registrar General, Historian General, Genealogist General, and Chaplain General of the National Society SAR. Also attending were 3 compatriots who are running for national office

The SC Society received many compliments from the National Officers and out of state guests on the reception and breakfast. I would again encourage as many SCSSAR members as can attend the Cowpens reception on Friday, 14 January 2011.

Looking forward to the 2011 Budget, it is recommended that the budget allocation remain the same.

**BY-LAWS OF THE SOUTH ATLANTIC DISTRICT
OF THE NATIONAL SOCIETY OF THE SONS OF THE AMERICAN REVOLUTION**

Adopted: 2 April 2011

Amended: _____

ARTICLE I – NAME & STATUS

The name of this District of the National Society of the Sons of the American Revolution shall be the "SOUTH ATLANTIC DISTRICT" (hereafter referred to as the District) as designated in Bylaw 5, Section 1, Sub-section (d) of the Bylaws of the National Society of the Sons of the American Revolution (hereafter referred to as the NSSAR). The District shall consist of the State Societies of North Carolina, South Carolina, Georgia and Florida.

ARTICLE II – OBJECTIVES

The objectives of the District are the same as those stated in Article II of the Constitution of the National Society of the Sons of the American Revolution.

"The objects of this Society are declared to be patriotic, historical, and educational, and shall include those intended or designed to perpetuate the memory of those patriot who, by their services or sacrifices during the war of the American Revolution, achieved the independence of the American people; to unite and promote fellowship among their descendants; to inspire them and the community-at-large with a more profound reverence for the principles of the government founded by our forefathers; to encourage historical research in relation to the American Revolution; to acquire and preserve the records of the individual services of the patriots of the war, as well as documents, relics, and landmarks; to mark the scenes of the Revolution by appropriate memorials; to celebrate the anniversaries of the prominent events of the war and of the Revolutionary period; to foster true patriotism; to maintain and extend the institutions of American freedom and to carry out the purposes expressed in the preamble of the Constitution of our country and the injunctions of Washington in his farewell address to the American people.

ARTICLE III – MEMBERSHIP

Section 1: Any member in good standing in one of the State Societies listed in Article I, including dual members whose primary state of membership is outside the District, shall be a member of the South Atlantic District of the NSSAR.

Section 2: Any member of the District shall be entitled to speak and vote at all District meetings.

ARTICLE IV – GOVERNING AUTHORITY

Section 1: The governing authority of the South Atlantic District shall consist of the Vice President General of the District (hereafter referred to as the Vice President General) and the Presidents of the State Societies listed in Article I (hereafter referred to as the Presidents).

Section 2: The Vice President General shall have the following duties and responsibilities:

- (a) Shall preside at all meetings of the District
- (b) Shall represent the District at the National Trustees Meetings and the NSSAR Annual Congress
- (c) Shall attend, whenever possible, the meetings of the State Societies and Chapters of the State Societies
- (d) Shall act as the official escort of the President General at events and meetings that occur within the

District unless the President General has made other arrangements

- ~~(e) Shall perform additional duties within the District as delegated or assigned to him by the President General, the Executive Committee of the NSSAR, or the Board of Trustees of the NSSAR~~
- (f) Shall call special meetings of the District whenever necessary
- (g) Shall submit the reports as required by the NSSAR Constitution and By-Laws or as requested by the President General, the Executive Committee of the NSSAR, or the Board of Trustees of the NSSAR
- (h) Shall submit to the Secretary General of the NSSAR and the Nominating Committee of the NSSAR the name of the District's nominee to serve as Vice President General of the South Atlantic District for the next term
- (i) Shall appoint a Secretary, Webmaster, and such other posts as deemed necessary for the functioning of the District
- (j) Shall maintain the history of the District to be published annually on the District website

Section 3: The District Secretary shall have the following duties and responsibilities:

- (a) Shall be responsible for keeping the minutes of the District meetings. Copies of said meetings shall be sent, via regular or electronic mail, to the Vice President General, the Presidents, the Webmaster, and the NSSAR Headquarters no later than thirty (30) days after a meeting is held.
- (b) Shall be responsible for notification of the time and place of District meetings. Notification shall be sent, via regular or electronic mail, to the Vice President General, the Presidents, the Webmaster, and the NSSAR Headquarters no later than thirty (30) days prior to said meeting.
- (c) Shall request and compile an Agenda and Reports Package to be sent, via regular mail or electronic mail, no later than seven (7) days prior to a District Meeting. The Reports Package shall contain a report from the Vice President General and Presidents on their and their State Society activities for the period since the previous District Meeting.

Section 4: The Webmaster shall have the following duties and responsibilities:

- (a) Shall maintain and regularly update the District website with information including, but not limited to, contact data for the Vice President General and the State Societies, a calendar of District events, copies of all minutes and report packages, and a history of the District.
- (b) Shall forward feedback and contact information received from the website to the Vice President General.

ARTICLE V – MEETINGS

Section 1: District Meetings shall consist of an Annual Meeting and as many other regular or special meetings as scheduled or called by the Vice President General. All meetings require a minimum of a thirty (30) day written notice by electronic mail or regular mail. Meeting dates, locations and times shall be chosen to convenience the greatest number of members as possible. The meeting held in conjunction with the Annual Meeting of the Vice-President General's State Society shall be the Annual Meeting of the District.

Section 2: The agenda of any regular meeting shall consist of the following:

- Call to order
- Invocation
- Pledge to the US Flag
- Pledge to the SAR
- Approval of the Minutes of the previous session
- Introduction of guests
- Remarks by the President General (if in attendance)

Remarks by the Vice President General

~~Remarks by the General Officers other than President General (if any in attendance)~~

Remarks by the State Society Presidents

Old Business

New Business

Round Table Discussion

Election of the District's nominee for Vice President General for the next term

(Annual Meeting only)

General Officer Candidates Forum (three (3) minutes per candidate or their representative)

Endorsement of General Officer Candidates (Fall meeting only)

SAR Recessional

Benediction

Adjournment

Section 3: For special called meetings, the notice of the meeting shall include the purpose for the special meeting and only those items properly disclosed for discussion may be considered for action.

Section 4: A quorum for any meeting shall consist of the Vice President General and 3 of the 4 Presidents or their official designee. In the case that any President cannot attend any District meeting, he shall notify the Vice President General and District Secretary of the name of their official designee no later than seven (7) days prior to the meeting.

ARTICLE VI – ELECTION OF THE VICE PRESIDENT GENERAL

Section 1: As stated in Bylaw 5 of the National Society Sons of the American Revolution, “there shall be one (1) Vice-President General elected from ... the ... District.” As stated in Article IV, Section 1 of the Constitution of the National Society Sons of the American Revolution, “the General Officers of this Society shall be ... a Vice-President General for each of the regularly established districts... who shall be elected ... at the Annual Congress.”

Section 2: The nomination of a candidate for Vice-President General shall be conducted on an annual rotating basis between the State Societies of the District. This rotation shall begin with the Florida Society in 2012, proceeding to the North Carolina Society, the South Carolina Society and the Georgia Society, in that order, on a perpetual basis.

Section 3: The State Society that is in rotation to nominate a candidate shall be viewed as the District's nominating committee in that year. The selection of the candidate for nominee shall be left to the State Society to complete in a manner of its own choosing. This candidate, once selected, shall be considered the candidate of the nominating committee. Upon selection, the State Secretary of the State Society making the nomination shall forward the name of the candidate in writing to the Vice-President General within thirty (30) days of the selection.

Section 4: At the Annual Meeting of the District the nominating committee as represented by the President of State Society that is in rotation to select a candidate for nomination, or his official designee, shall place the name of the candidate in nomination for ratification by the members of the District.

Section 5: In accordance with the National Constitution and By-laws, nominations of any member of the State

Society whose right it is to nominate a candidate may be made from the floor by any member of that State Society. ~~Prior notice is not required and the nominee does not have to be present at election, but his consent is required.~~

Section 6: The District shall vote on the candidate(s) in a manner consistent with the procedure for the election of General Officers of the NSSAR. Upon election, the candidate for the office of Vice-President General shall be considered the nominee of the District.

Section 7: The current Vice-President General shall forward the name of the District's nominee to the Secretary General and the chairman of the Nominating Committee of the NSSAR in writing no later than thirty (30) days after the Annual Meeting of the District.

ARTICLE VII – PARLIAMENTARY AUTHORITY

The rules set forth in the most current edition of *Robert's Rules of Order, Newly Revised* shall govern the District in all meetings in which they are not inconsistent with these By-Laws and any special rules of order that the District may adopt.

ARTICLE VIII – AMENDMENTS

Proposed amendments to these By-Laws shall be submitted in writing to the Vice President General, the Presidents, and the District Secretary no later than twenty (20) days prior to a regularly scheduled District Meeting and shall require a two-thirds (2/3) affirmative vote of those members present and voting at the meeting for approval.

meeting will be final weekend of month where youth programs will be judged. Compatriot Charlie Newcomer complements Florida Society on membership drive efforts and *Florida Patriot*. Compatriot Lindsey Brock mentions health concerns of the editor that are very severe.

- e. VPG – cites tentative schedule and references perspective – need for members to “buy into” the programs and activities as well as with fund raising efforts, references efforts to renovate his own church and importance of getting people to pledge instead of trying to collect offerings

5) Patriotic Education Roundtable

- a. VPG Corbett sets stage for discussion by stating that this is an opportunity to discuss various state society efforts on various topics as a method to share best practices. The focus in this meeting is based on observations that many school children do not know Revolutionary History.
- b. Many examples are provided to support this
- c. Mike Tomme mentions reticence of members to speak publicly and curriculum / test score driven teaching
- d. Mark Anthony mentions finding a niche in schedule where curriculum is not planned at quarter or term end
- e. Tomme mentions not being afraid to make mistakes and using experience to learn more. GA has 8 of 29 chapters that are presenting in classrooms and at any other venue where asked

- g. Horton mentions using library as teaching venue by providing program where library may not have that type of program

South Carolina – promoting all youth programs with mixed results and trying to push more involvement from chapters, various individuals have developed programs for presentation on behalf of chapters, Cambridge chapter makes specific emphasis on connection between youth awards and the SAR as part of presentations; beginning effort to have chapters put up historical markers, state offers a \$1,000 scholarship each year but only had 2 applicants in 2010 attributed to lack of communication
  - ii. Florida – have 32 chapters with only 9 eagle scout applications so far, comments on how the same entry material can be used in multiple contests with small adaptations – essay, eagle, oration, eagle, take of presenting good citizenship certificates to other students when recognizing winners in poster contest, focus on existing relationships with JROTC units and building same with home school associations which are easier to get into than public schools
  - iii. North Carolina – does typical programs but have found that participation is driven by interest and drive found within local chapters, have found that local chapter efforts have shown limited success, have better success from home schools, use local revolutionary war roundtables as means of getting communication out, based on efforts it seems that kids currently do not want to put forth the effort when it comes to program requirements
  - iv. Georgia – state offers a Social Studies teacher award and awards to a non-teacher that makes revolutionary war presentations for a man and woman, push JROTC and the enhanced part in terms of scholarship money; try to focus on award money on national awards; reinstating oration contest after many years of not doing this – it is starting slowly but it is growing, can report that poster contest on national level had 11 entries, recommends developing a state level award to recognize individuals that, have a state distinguished award for those chapters that meet certain

educational goals, presenting at state level home school meeting each year as a recruiting tool as well as presenting what the state society offers, know that only 19-20 cadets apply for national award, submissions to these contests are based on personal relationships that have been built between chapters and local schools or similar entities, state has developed 2 traveling trunks that contain artifacts (lead ball, flint & steel, Betsy Ross flag, etc) that can be bought related to the revolution that are shared between chapters for presentation at schools that anyone can talk about instead of a specific program, success is derived from being creative

    - b. Marion Park is a National Park located on South Carolina Avenue in southeast DC but has no memorial and website on DC parks lists only Marion's state senate service
    - c. Took 3 years of testifying before Congress to get required Act of Congress and bill signed by president to have a statue placed on federal land
    - d. This is a 23 step process that can be summarized into 5 major steps: 1<sup>st</sup> was approval, 2<sup>nd</sup> is get statues approved, 3<sup>rd</sup> is get architectural design approved. These last 2 steps are where the process is now. Committee has officially completed 8 steps
    - e. Currently fund raising through Swamp Fox Challenge through SC schools having raised \$10,000. Will need \$500,000
    - f. Website is [www.swampfoxmemorial.com](http://www.swampfoxmemorial.com)
    - g. Getting interest from many states including Oregon and California due to 16 counties and 29 cities named for Marion
    - h. Question on work at Marion gravesite and answer is that state has appropriated funds to upgrade that site.
    - i. Doster recognized to mention new Marion Statue that is being placed in Johnsonville, SC on the Lynches River which has been paid for (\$85,000). Efforts are currently underway to raise funds for the pedestal (need \$16,000). Proposed dedication date is in July.
  12. Corbett speaks to Marion's gravesite
    - a. On private land still owned by Marion Family members who allow access
    - b. States that there is a need to purchase this land on behalf of the state
    - c. Ohanesian states that the SC Society has approached approved a motion to ask the state to do this but this has not been done and probably would not be well received in the current economic state
    - d. Brock suggests potential family donation of land – but believe it would be conditioned on private funding of any development
    - e. Morton states that DAR was presented with \$50,000 two years ago to do needed restoration work even though they did not ask for it

**BY-LAWS OF THE SOUTH ATLANTIC DISTRICT  
OF THE NATIONAL SOCIETY OF THE SONS OF THE AMERICAN REVOLUTION**

**Adopted: 2 April 2011**

**Amended: \_\_\_\_\_**

**ARTICLE I – NAME & STATUS**

The name of this District of the National Society of the Sons of the American Revolution shall be the "SOUTH ATLANTIC DISTRICT" (hereafter referred to as the District) as designated in Bylaw 5, Section 1, Sub-section (d) of the Bylaws of the National Society of the Sons of the American Revolution (hereafter referred to as the NSSAR). The District shall consist of the State Societies of North Carolina, South Carolina, Georgia and Florida.

**ARTICLE II – OBJECTIVES**

The objectives of the District are the same as those stated in Article II of the Constitution of the National Society of the Sons of the American Revolution.

*"The objects of this Society are declared to be patriotic, historical, and educational, and shall include those intended or designed to perpetuate the memory of those patriot who, by their services or sacrifices during the war of the American Revolution, achieved the independence of the American people; to unite and promote fellowship among their descendants; to inspire them and the community-at-large with a more profound reverence for the principles of the government founded by our forefathers; to encourage historical research in relation to the American Revolution; to acquire and preserve the records of the individual services of the patriots of the war, as well as documents, relics, and landmarks; to mark the scenes of the Revolution by appropriate memorials; to celebrate the anniversaries of the prominent events of the war and of the Revolutionary period; to foster true patriotism; to maintain and extend the institutions of American freedom and to carry out the purposes expressed in the preamble of the Constitution of our country and the injunctions of Washington in his farewell address to the American people.*

**ARTICLE III – MEMBERSHIP**

Section 1: Any member in good standing in one of the State Societies listed in Article I, including dual members whose primary state of membership is outside the District, shall be a member of the South Atlantic District of the NSSAR.

Section 2: Any member of the District shall be entitled to speak and vote at all District meetings.

**ARTICLE IV – GOVERNING AUTHORITY**

Section 1: The governing authority of the South Atlantic District shall consist of the Vice President General of the District (hereafter referred to as the Vice President General) and the Presidents of the State Societies listed in Article I (hereafter referred to as the Presidents).

Section 2: The Vice President General shall have the following duties and responsibilities:

- (a) Shall preside at all meetings of the District
- (b) Shall represent the District at the National Trustees Meetings and the NSSAR Annual Congress
- (c) Shall attend, whenever possible, the meetings of the State Societies and Chapters of the State Societies
- (d) Shall act as the official escort of the President General at events and meetings that occur within the



District unless the President General has made other arrangements

- ~~(e) Shall perform additional duties within the District as delegated or assigned to him by the President~~ General, the Executive Committee of the NSSAR, or the Board of Trustees of the NSSAR
- (f) Shall call special meetings of the District whenever necessary
- (g) Shall submit the reports as required by the NSSAR Constitution and By-Laws or as requested by the President General, the Executive Committee of the NSSAR, or the Board of Trustees of the NSSAR
- (h) Shall submit to the Secretary General of the NSSAR and the Nominating Committee of the NSSAR the name of the District's nominee to serve as Vice President General of the South Atlantic District for the next term
- (i) Shall appoint a Secretary, Webmaster, and such other posts as deemed necessary for the functioning of the District
- (j) Shall maintain the history of the District to be published annually on the District website

Section 3: The District Secretary shall have the following duties and responsibilities:

- (a) Shall be responsible for keeping the minutes of the District meetings. Copies of said meetings shall be sent, via regular or electronic mail, to the Vice President General, the Presidents, the Webmaster, and the NSSAR Headquarters no later than thirty (30) days after a meeting is held.
- (b) Shall be responsible for notification of the time and place of District meetings. Notification shall be sent, via regular or electronic mail, to the Vice President General, the Presidents, the Webmaster, and the NSSAR Headquarters no later than thirty (30) days prior to said meeting.
- (c) Shall request and compile an Agenda and Reports Package to be sent, via regular mail or electronic mail, no later than seven (7) days prior to a District Meeting. The Reports Package shall contain a report from the Vice President General and Presidents on their and their State Society activities for the period since the previous District Meeting.

Section 4: The Webmaster shall have the following duties and responsibilities:

- (a) Shall maintain and regularly update the District website with information including, but not limited to, contact data for the Vice President General and the State Societies, a calendar of District events, copies of all minutes and report packages, and a history of the District.
- (b) Shall forward feedback and contact information received from the website to the Vice President General.

#### ARTICLE V – MEETINGS

Section 1: District Meetings shall consist of an Annual Meeting and as many other regular or special meetings as scheduled or called by the Vice President General. All meetings require a minimum of a thirty (30) day written notice by electronic mail or regular mail. Meeting dates, locations and times shall be chosen to convenience the greatest number of members as possible. The meeting held in conjunction with the Annual Meeting of the Vice-President General's State Society shall be the Annual Meeting of the District.

Section 2: The agenda of any regular meeting shall consist of the following:

- Call to order
- Invocation
- Pledge to the US Flag
- Pledge to the SAR
- Approval of the Minutes of the previous session
- Introduction of guests
- Remarks by the President General (if in attendance)

Remarks by the Vice President General

~~Remarks by the General Officers other than President General (if any in attendance)~~

Remarks by the State Society Presidents

Old Business

New Business

Round Table Discussion

Election of the District's nominee for Vice President General for the next term

(Annual Meeting only)

Adjournment

Section 3: For special called meetings, the notice of the meeting shall include the purpose for the special meeting and only those items properly disclosed for discussion may be considered for action.

Section 4: A quorum for any meeting shall consist of the Vice President General and 3 of the 4 Presidents or their official designee. In the case that any President cannot attend any District meeting, he shall notify the Vice President General and District Secretary of the name of their official designee no later than seven (7) days prior to the meeting.

#### ARTICLE VI – ELECTION OF THE VICE PRESIDENT GENERAL

Section 1: As stated in Bylaw 5 of the National Society Sons of the American Revolution, “there shall be one (1) Vice-President General elected from ... the ... District.” As stated in Article IV, Section 1 of the Constitution of the National Society Sons of the American Revolution, “the General Officers of this Society shall be ... a Vice-President General for each of the regularly established districts...who shall be elected ... at the Annual Congress.”

Section 2: The nomination of a candidate for Vice-President General shall be conducted on an annual rotating basis between the State Societies of the District. This rotation shall begin with the Florida Society in 2012, proceeding to the North Carolina Society, the South Carolina Society and the Georgia Society, in that order, on a perpetual basis.

Section 3: The State Society that is in rotation to nominate a candidate shall be viewed as the District's nominating committee in that year. The selection of the candidate for nominee shall be left to the State Society to complete in a manner of its own choosing. This candidate, once selected, shall be considered the candidate of the nominating committee. Upon selection, the State Secretary of the State Society making the nomination shall forward the name of the candidate in writing to the Vice-President General within thirty (30) days of the selection.

Section 4: At the Annual Meeting of the District the nominating committee as represented by the President of State Society that is in rotation to select a candidate for nomination, or his official designee, shall place the name of the candidate in nomination for ratification by the members of the District.

Section 5: In accordance with the National Constitution and By-laws, nominations of any member of the State



Society whose right it is to nominate a candidate may be made from the floor by any member of that State Society. ~~Prior notice is not required and the nominee does not have to be present at election, but his consent is required.~~

Section 6: The District shall vote on the candidate(s) in a manner consistent with the procedure for the election of General Officers of the NSSAR. Upon election, the candidate for the office of Vice-President General shall be considered the nominee of the District.

Section 7: The current Vice-President General shall forward the name of the District's nominee to the Secretary General and the chairman of the Nominating Committee of the NSSAR in writing no later than thirty (30) days after the Annual Meeting of the District.

#### ARTICLE VII – PARLIAMENTARY AUTHORITY

The rules set forth in the most current edition of *Robert's Rules of Order, Newly Revised* shall govern the District in all meetings in which they are not inconsistent with these By-Laws and any special rules of order that the District may adopt.

#### ARTICLE VIII – AMENDMENTS

Proposed amendments to these By-Laws shall be submitted in writing to the Vice President General, the Presidents, and the District Secretary no later than twenty (20) days prior to a regularly scheduled District Meeting and shall require a two-thirds (2/3) affirmative vote of those members present and voting at the meeting for approval.

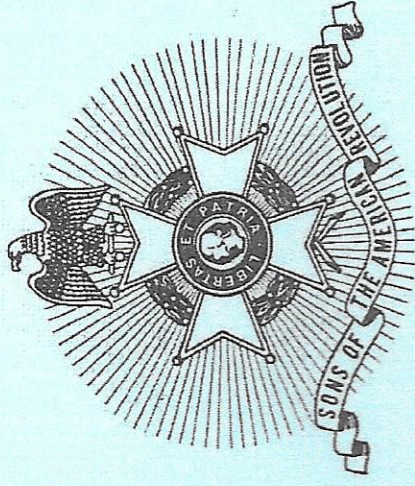
The South Carolina Society: Who We Are

The South Carolina Society began granting charters to chapters in 1923. Currently seventeen chapters promote the American spirit through fraternal meetings, commemorative observances of events and battles, educational materials, projects, lectures, tours and publications. From the mountains to the coast, South Carolina experienced the most battles and skirmishes of the war.

Since the organization of the South Carolina Society, over 3,000 compatriots have filled the membership ranks. The present membership is about 700.

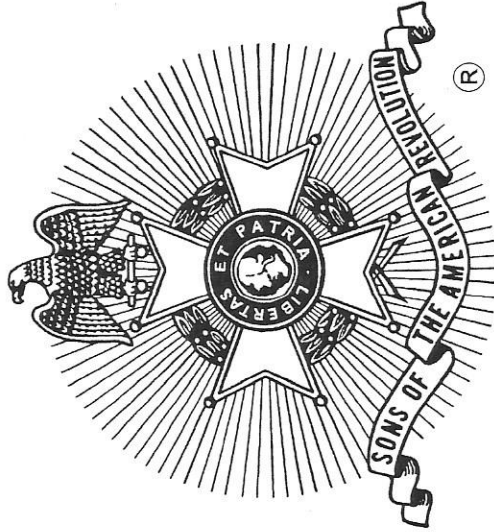

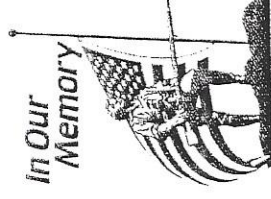

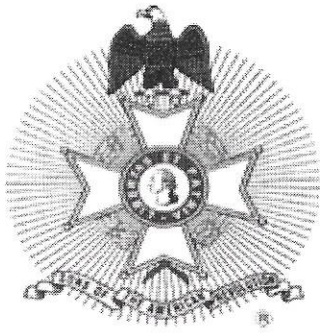
